A 90% federal share may be requested for vehicle-related equipment and facilities required by the Clean Air Act (CAA) or the Americans with Disabilities Act (ADA). Overmatching JARC funds is permissible and encouraged. Overmatching will improve the project score for Cost/Benefit Analysis. *(Up to 3 points are possible for overmatching.)*

Matching Funds

Matching funds are required for all applications and must be derived from non-DOT (not from the U.S. Department of Transportation) funding sources. Please note that income from contracts to provide human service transportation may be used either to reduce the net project cost (treated as revenue) or as local matching funds for operating activities. Fare box revenue may also be used to reduce the net project cost, but cannot be used as local matching funds.

Accuracy of scoring depends upon the completeness and level of detail of information provided by the applicant.
