V. GSR & 9-1-1 SYSTEMS UPDATE

Brent Hawkinson spoke briefly on the Viper IP Phone Set w/ ALI. ACOG has purchased a "Viper IP Phone Set w/ ALI" from Intrado for testing purposes, and technical staff has installed it in the Training PSAP.

He also said the ASAP (ACOG Support & Assistance Program) statistics and analytics regarding trouble reports to 9-1-1 Technical Support. The statistics and analytics were provided at the back table: These statistics include Calls to the ASAP Helpdesk, emails to help@911acog.org, and SysAid Portal notifications.

VI. 9-1-1 EDUCATION UPDATE

Lysa Baker discussed the new software from Both Worlds Software for creating and maintaining records through a database for dispatcher training. She also has training classes scheduled up to June.

VII. 9-1-1 GIS UPDATE

Mike Davis provided the Technical Committee with a briefing on the Address Point Layer, GeoLynx Server Update, and the Aerial Update.

Mike said GIS (Geographic Information System) map layering is an ongoing process and staff continues to work on it.

Mike gave a brief discussion on the GeoLynx Server update, staff has been implementing an update that will fix the zooming issues that are present and some smaller issues. The update will be after the Multi-node has been completed.

Mike spoke briefly about the Aerial Updates.

VIII. <u>NEW BUSINESS</u>

Brent Hawkinson gave a brief discussion on the meeting which was held on October 20, 2015 with Oklahoma City to discuss the Text to 911. This is going to be a mutual task between ACOG and Oklahoma City.

Carl Bane, Sales Engineer with Intrado discussed ways to carefully migrate to a fully managed, complete NG 9-1-1 solution, adhering to i3 standards. He also discussed Text to 911. He discussed the critical success factors such as a reliable network, a fully integrated and secure delivery platform, the ability to support existing E9-1-1 functions, and emerging non-voice technology features.
