I. Welcome and Introductions

Mayor Mick Cornett called the meeting to order. RTA Task Force members and alternates introduced themselves and who they represent. Mayor Collins introduced Matt Dukes, mayor-elect of Midwest City.

II. Approval of January 20, 2016 RTA Task Force Meeting Minutes

Mayor Cindy Rosenthal made a motion to approve the minutes of the January 20, 2016 meeting. Councilman Hamm seconded the motion, and the motion carried.

III. <u>Proposed Bylaws for the RTA Task Force</u>

John G. Johnson highlighted a revision to the proposed bylaws concerning Article IV, Sec. 7, *Majority Vote*, to address discussion from the January 20 RTA Task Force meeting. He said that, in January, it was discussed that the *Majority Vote* language could result in decisions being made by just three of the six voting Task Force members, as previously written.

The revised language would change the voting majority requirement to three-quarters (3/4) of the quorum, which would be four voting members or their alternates. If the voting membership of the Task Force increases, the new language will ensure a larger majority vote requirement in relation to its quorum.

Councilwoman Waner made a motion to approve the proposed bylaws of the RTA Task Force. Mayor Collins seconded the motion, and the motion carried with the following vote:

AYE: Linley, Waner, Collins, Hamm, Rosenthal, Cornett

NAY: None

IV. Election of RTA Task Force Officers

Mr. Johnson stated that this item was also discussed at the January meeting with no action taken at that time. He said several members indicated Mayor Cornett would be a good choice for Chair, and Mayor Rosenthal previously indicated her willingness to serve as Vice Chair. Both nominees advised that they would accept their nominations.

Councilwoman Waner made a motion to elect Mayor Mick Cornett as RTA Task Force Chair and Mayor Cindy Rosenthal as Vice-Chair. Mayor Collins seconded the motion, and the motion carried with the following vote:

AYE: Linley, Waner, Collins, Hamm, Rosenthal, Cornett

NAY: None

V. Activity Log of 2016 RTA Task Force Meetings

John Johnson explained that this item was similar to information brought to the Task Force in January; however, it provides a series of topics for discussion and/or action by the Task Force, without identifying their specific order or meeting date.

Mayor Cornett stated he felt the next topic that needs to be discussed is baseline polling to determine the level of general support for transit within the region to determine where transit would most likely be supported and where more education is needed. Also, the polling would help identify what "transit" means to the public, and what type of taxation they would be willing to support to receive the transit they desire. He recommended that this be placed on the next agenda.

Mayor Rosenthal said she believes the Task Force should be able to proceed with decisions about the RTA boundary and governance at the same time the polling is being conducted.

Mr. Johnson advised that a request for proposals would have to be prepared and a pollster selected through a competitive bidding process. Holly Massie reminded the members that federal funds cannot be used for polling. However, ACOG could assist with putting together the request for proposals (RFP).

Mayor Cornett asked about assistance from the Greater OKC Chamber. Derek Sparks said the Chamber has supported previous Oklahoma City and Oklahoma County initiatives and believes they would be willing to consider this request. He mentioned that the Chamber Steering Committee is meeting currently to develop its 5-year economic development plan, which approximately 180 companies underwrite. A portion of their funds have been spent on polling in the past. Mr. Sparks said he would update Roy Williams concerning the assistance the Task Force is requesting. Mayor Cornett said we are needing someone to develop the RFP for polling and to fund it.

VI. <u>Draft Scope of Work for Consultant Services for Planning Assistance</u>

John Johnson stated that, as we move forward with developing the legal framework and structure of the Regional Transit Authority, we are at a position that expert assistance is needed beyond that of the ACOG staff. He said that the draft scope of work in the agenda is staff's first attempt to identify the type of assistance needed, and the preferred final scope would be incorporated into an RFP consistent with requirements of our federal funding partners.

Mayor Cornett expressed concern with spending money to hire someone prior to conducting the polling. He asked Jason Ferbrache about the type of expertise COTPA has on staff. Mr. Ferbrache advised that COTPA has a couple of planners, but does not have staff expertise on how RTAs operate in other areas or anyone with experience working with a transit authority.

There was discussion about the need for the Task Force to review the boundary and governance recommendations from phase one of the Regional Transit Dialogue prior to hiring a consultant. Holly Massie mentioned that these review efforts could be undertaken at the same time staff is working to complete and issue an RFP, receive proposals, conduct interviews and make a selection in order to be efficient with everyone's time.

Mayor Cornett asked what services a new consultant would provide that we did not receive last time. Mr. Johnson said they would provide assistance with the formation of the Regional Transit Authority Memorandum of Agreement that would formalize the structure of the RTA that each city council would adopt in order to be part of the RTA. Compliance with federal planning and funding requirements would also be necessary. He said the RTA will be a new political body and this is a road the region has not been down before; hence, the advice and counsel of someone with this type of knowledge is needed.

Derek Sparks advised that the Chamber relies heavily on polling data for the items it supports. Mr. Sparks will coordinate with ACOG about the support/role the Chamber can play in polling after discussing it with the director so that more information can be provided in the next meeting.

VII. Review of RTA Geography Scenarios from Regional Transit Dialogue

John Johnson gave a presentation on the boundary scenarios that were developed during the first phase of the Regional Transit Dialogue (RTD). The three models evaluated were the county model, city model, and district model. Both the county and city models would utilize existing geopolitical boundaries consisting of whole counties or cities. This would result in large portions of the RTA district being outside the foreseeable transit service area. The district model would be a new geopolitical boundary based on the region's census-designated urbanized areas, population and employment densities, and voting precinct boundaries. The new district would reflect the portion of the metro area where regional transit would most likely occur over the coming decades. The RTD committees also developed scenarios for potential subdistrict geography for representation on an RTA governing body. VIII. New Business

Mayor Cornett provided a brief update on the MAPS 3 streetcar, saying that the first tracks will be put in the ground in late 2016 as part of redesigning E.K. Gaylord Boulevard in front of Santa Fe Station. The street redesign will reflect the Project 180 standard of narrowing the street, adding landscaping and making it more pedestrian friendly, with the streetcar tracks being laid at that time. He said both the streetcar and Santa Fe hub improvements will get the public thinking about transit as never before, and by 2018 the streetcar system should be in operation.

Mayor Cornett complimented the boundary presentation slides, and Elizabeth Waner said that it provides a nice segway into governance.
