### IV. DIRECTOR'S REPORT

John Johnson reminded everyone of HB 3126. He said the bill has passed in the House and now the bill has gone to the Senate.

### V. GSR & 9-1-1 SYSTEMS UPDATE

Robin Murray discussed the Newcastle AT&T 4Mb Metro-E Circuit. She gave a brief discussion on TXT29-1-1 and the progress we are making with TXT29-1-1. Robin gave an update on the Nichols Hills PSAP move to the Village PSAP.

She also said that Intrado will no longer sell the ESINET and AT&T will be the one for the ESINET solution.

Robin Murray spoke briefly on the Viper IP Phone Set w/ ALI. ACOG has purchased a "Viper IP Phone Set w/ ALI" from Intrado for testing purposes, and technical staff has installed it in the Training PSAP.

She also said the ASAP (ACOG Support & Assistance Program) statistics and analytics regarding trouble reports to 9-1-1 Technical Support. The statistics and analytics were provided at the back table. These statistics include Calls to the ASAP Helpdesk, emails to [help@911acog.org](mailto:help@911acog.org), and SysAid Portal notifications. The PSAP Call Volume Statistics were also provided at the back table.

### VI. 9-1-1 EDUCATION UPDATE

She also discussed National Telecommunicator Week which is April 10-16, 2016. The theme this year is Protecting the Three. **Lead, Follow, or Get out of the Way June 9, 2016:**

Leadership is more than being an appointed supervisor. Everyone in your communications center has the possibility for leadership. This one of a kind leadership class will address leadership at all levels of your organization and provide attendees with ways to improve the leadership in your communications center. Instructor Tony Harrison ENP

**APCO Communications Training Officer (CTO) June 22-24, 2016:** APCO Institute's 5th Edition of their premier training program the Communications Training Officer (CTO) course focuses on the development and maintenance of an agency's one-on-one training program and provides the training necessary to foster levels of consistency for CTOs as they provide on-the-job training to new hires. This updated version of the course includes the essential elements of a CTO program based on the industry recognized "San Jose Model" while also incorporating the requirements set by the national standard for CTO programs – APCO ANS 3.101.1-2007: Minimum Training Standards for Public Safety Communications Training Officers. Instructor Lysa Baker: ENP, RPL

**Topics include:** Performance Based Training, Preparing, Motivating and Communicating With Trainees, Customer Service in Public Safety Communications, Counseling, Stress Management, Meeting the Needs of the Adult Learner, Training Strategies, Performance Evaluations, Record Keeping and Documentation, Total Quality Management, Liability and Standards.

Students will receive a CTO Workbook and Reference Guide filled with sample forms, templates and best practices to use in creating their own CTO program or enhancing an existing program. Students will also receive a demonstration of APCO Institute's electronic Daily Observation Report (DOR) software.

**Prerequisites:**

Students must have successfully completed a formal basic Telecommunicator training program

**Critical Incidents Total Disaster Response July 15, 2016:** Learn about how to be prepared to deal with critical incidents within the communications center. Instructor Tony Harrison ENP

**Topics Include:** Threat assessment, prepare yourself, Prepare your agency, Terrorism, Threat assessment, Disaster response, handling 9-1-1 during large scale incidents, Case studies, Lessons learned.

**Introduction to 9-1-1 Management (NEW CLASS) September 9, 2016:** This course will introduce new and experienced 9-1-1 managers to various topics and situations within the communications center. Instructor: Barry Furey

**Topics Include:** Basic telephone technology, PSAP systems, CAD & GIS, Disaster management, Personnel issues, Sexual harassment, Leadership, NG 9-1-1, Radio systems, Gossip, handling challenging employees, cliques and complaints.

**APCO Communications Center Supervisor August 31 – September 2, 2016:** The APCO Institute Communications Center Supervisor course is designed for prospective, new or experienced communications supervisors who want to enhance their supervisory skills and knowledge. Class lecture is supplemented by practical exercises that help students apply the lessons to their own agency policies and procedures. Students not only learn supervisory topics, but also learn how to work together in groups and cooperate to attain common goals. Instructor: Lysa Baker ENP, RPL

**Topics include:** The Telecommunications Supervisor Role, Liability Issues for Supervisors, Policies, Procedures and Directives, Communication Skills, Self-Assessment, Employee Evaluation and Motivation

**Prerequisites:**

*Students should be experienced in Communications Center operations, have a working knowledge of communications policies and procedures and be either in or under consideration for a supervisory position within the agency.*

**APCO Public Safety Telecommunicator I (New 7<sup>th</sup> Edition) September 19-23, 2016:** The APCO Institute PST course is the week long class and may be used for new-hire and existing employee training. The PST basic training course meets and exceeds the APCO Project 33 Revised Minimum Training Standards for Public Safety Telecommunicators (2004). APCO Project 33 training standards are widely recognized as the national industry standard for basic telecommunicator training. The PST course blends the knowledge and skill building information needed for a basic telecommunicator with the most up-to-date information on the technology and issues in public safety communications centers. Topics include the telecommunicator's role in the U.S. Department of Homeland Security's NIMS Incident Command System. Instructor: Lysa Baker ENP, RPL
