## A. <u>CALL TO ORDER</u>

Chairman Pete White called the meeting to order at 1:41 p.m., welcoming all in attendance. ACOG Executive Director John G. Johnson called the roll, stating that a quorum was present. He then welcomed the guests.

# B. APPROVAL OF THE NOVEMBER 17, 2016 MINUTES

Councilmember John Brown moved to approve the November 17, 2016 minutes. Mayor Ray Poland seconded the motion. The motion carried.

Mayor Ray Poland moved to place Items C-1 through C-4 on the Consent Docket and approve or acknowledge those items, subject to any conditions included in those items. Commissioner Marven Goodman seconded the motion. The motion carried.

#### D. ITEMS REQUIRING INDIVIDUAL ACTION AND/OR DISCUSSION:

# 1. <u>FINAL LETTER AND REPORT OF THE QUADRENNIAL FEDERAL JOINT CERTIFICATION REVIEW</u> OF THE OCARTS METROPOLITAN PLANNING ORGANIZATION

John G. Johnson said representatives were here today to share the results of the final report of the Quadrennial Federal Joint Certification Review. He said a copy of the letter was available at the table.

Isaac Akem introduced Basharat Siddiqi, the Administrator of the Oklahoma Division of FHWA. Mr. Siddiqi said this was the first ITPC meeting he has attended and wanted to thank those who participated in the certification review. He said it was a joint review by FHWA and FTA about ACOG's transportation planning process, which they found to be consistent with federal planning requirements. Therefore, ACOG is certified for the next four years. He thanked John G. Johnson for all his work and effort within a very short

window of time in preparing for and participating in the process. He said it was an effort that ended in a very positive manner.

He also thanked others who participated, to include Hon. Pete White, Mayor Jay Adams, Jason Ferbrache, the ODOT partners and transit providers: COTPA, CART and Citylink.

Isaac Akem added that everything looked good in the Certification Review. He said FHWA and FTA look to see if the MPO is using the federal funds properly in developing the planning products, which include the Encompass 2040 Plan, the Transportation Improvement Program, the Unified Planning Work Program, and the Congestion Management Plan. They make sure the products are all done in accordance with the federal regulations, and ACOG has done very well at developing all the documents.

Mr. Akem said they commended ACOG staff for:

- Using fiscal constraint, which is a provision in the law that says you cannot get a number of projects for which you do not have sufficient funds. He said ACOG was able to account for all the funding that is coming into the area.
- Incorporating performance measures into the planning process, by taking the initiative to show that the performance measures are being identified, particularly when developing the Congestion Management Plan.
- Using a FHWA method called the National Performance Management Research Data Set (NPMRDS) effectively.
- Using Scenario Planning in the Encompass 2040 Plan, which is a new concept of identifying scenarios of what the future will look like and transportation facilities that will be associated with those scenarios. He said scenario planning is still a developing concept and he was happy that ACOG staff was able to perform this cutting edge approach.

Mr. Akem closed by saying FHWA and FTA found the transportation planning process being conducted in accordance with federal regulations. He said there was no finding to inhibit ACOG's continued use of federal funds.

There was no discussion. The Committee received the Final Report of the Quadrennial Joint Certification Review of OCARTS Metropolitan Planning Organization.

# 2. TRANSPORTATION NEWS AND UPDATE

John Johnson said he was pleased to introduce John Sharp as the new Division Director for the Transportation & Planning Services Division. He said Mr. Sharp was instrumental in the foundation for much of the good report from FHWA. He thanked John Sharp and wished him well.

John Sharp thanked Mr. Johnson and proceeded to give some updates.

# FFY 2017-2020 Transportation Improvement Program (TIP) Projects

Mr. Sharp said the FFY 2017-2020 TIP project applications are due tomorrow (December 16) and thanked all the entities for working hard to meet the deadline.

# <u>Transportation Alternatives Program (TAP) Grants</u>

Mr. Sharp said in the spring there will be an application process for the Transportation Alternatives Program (TAP) grants. He said there is approximately \$8.4 million worth of grant money with an 80/20 percent split required. It is for bike-ped related projects. There will be a workshop in the spring for entity staff members to get a better understanding of the parameters of the grants.

#### Final Rule for the FAST Act

Mr. Sharp said today word was given on the final rulemaking on the FAST Act and how it pertains to MPOs and DOTs. He said ACOG will be reviewing it over the next week to see if there are any changes that need to be taken into account for the MPO and how it relates to FHWA and FTA.

# E. NEW BUSINESS

Chairman White asked if there was any new business to present.

# 9-1-1 Board of Directors Quorum Question

Referring back to the 9-1-1 BOD meeting, Councilmember Jim Pumphrey asked if John Johnson had been able to work on what the quorum must be for 9-1-1. Mr. Johnson said no, that it is a bigger question in his mind because it would involve thinking about changing the structure towards an executive committee and reducing the number of people who meet on a monthly basis, but then would meet quarterly or semi-annually for the whole group. Therefore, that will be heavy lifting about what that language will be in the bylaws. He said that was on his "to do" list.

## TIP Applications - Request for Resolution in Accessing ODOT Database Records

Commissioner Marven Goodman said the database of record for certain pieces of information that the entities need and must have to fill out the TIP applications is maintained by 0D0T and the information is required by 0D0T on the forms, but when the information is requested, 0D0T has required Logan County to fill out an Open Records request. Commissioner Goodman said that was done this year but has not been developed yet. He asked that an agenda item for discussion and action be added to next month's agenda to get some resolution about the process. Mr. Johnson said that item would be added to next month's agenda. Also, he said the Oklahoma Secretary of Transportation, Mr. Gary Ridley, would be here today if he wished to discuss the issue with him.

On January 19, 2017, the Intermodal Transportation Technical Committee (ITTC) held a special meeting to review and prioritize project proposals for *updating* the Surface Transportation Program Urbanized Area (STP-UZA) projects included in the current OCARTS Area TIP. The attached tables reflect the ITTC's recommendations for updating the FFY 2018, FFY 2019 and FFY 2020 local government projects. This update will ensure that the TIP reflects local priorities for expending the region's STP-UZA funds until a new TIP is prepared next year.

To ensure that the OCARTS Area Transportation Improvement Program (TIP) will remain financially constrained, an estimated apportionment of STP-UZA funds for the Oklahoma City Urbanized Area has been developed in consultation with the Programs Division of the Oklahoma Department of Transportation (ODOT). The figures below reflect the estimated STP-UZA apportionment<sup>1</sup> that will be received in FFY 2018.

In FFY 2015 and FFY 2016, the OCARTS area STP-UZA funds exceeded the STP-UZA limitations. The cost overruns were \$1,198,900 and \$2,692,900, respectively. OCARTS area TAP funds were used to balance the STP program. In order to balance the funds and rectify these overruns, staff recommended to the ITTC that \$1,000,000 be subtracted from the initial estimated apportionment for each federal fiscal year.

As required by the FAST Act, a year-of-expenditure inflation factor is also applied to the project cost estimates submitted by the project sponsors. Inflation factors of 3, 6, and 9 percent are being used for FFY 2018, 2019, and 2020, respectively.<sup>2</sup>

ACOG's <u>STP Procedures for the Oklahoma City Urbanized Area Funds</u> call for 90 percent of the estimated apportionment to be used in preparing the TIP. This is intended to avoid a shortage of funds at the end of the fiscal year due to changes in cost estimates or unanticipated high bids. Also, federal rules allow 10 percent of the estimated STP distribution to be used to finance 100 percent of the construction cost of eligible safety projects. Below are the estimated annual STP-UZA (80% federal) and STP-UZA Safety [100% federal] funds to be used to update the FFY 2017-2020 TIP.

**SUBJECT:** Selection of FY 2017, Round 1, ACOG Public Fleet CLEAN AIR Grants Projects

#### INFORMATION:

On October 3, 2016 the Association of Central Oklahoma Governments (ACOG) issued its ACOG FY 2017 Public Fleet CLEAN AIR Grants call for projects.

Congestion Mitigation and Air Quality (CMAQ) funds assigned to the Oklahoma City Area Regional Transportation Study (OCARTS) area provide the resources for these competitive grant awards. Eligible projects include fleet conversion to clean fuel technologies, the acquisition of alternative fuel or hybrid vehicles, and/or the purchase and installation of alternative fuel vehicle refueling or recharging infrastructure.

Eligible entities include: Oklahoma City Area Regional Transportation Study (OCARTS) local government member entities, OCARTS member public transit fleets, Public Trusts and Public Authorities that provide essential services to OCARTS member entities, Public colleges and universities, and Oklahoma CareerTech System Technology Centers lying principally within OCARTS boundaries, Public school districts lying principally within OCARTS boundaries, and Public-Private Partnerships (PPP). Private sector entities that contract services such as refuse hauling or school transportation or the establishment of alternative fueling station operations and maintenance to eligible OCARTS-area public entities are eligible to apply for funding.

Only the incremental cost of a vehicle's alternative fuel system can be considered for funding under CMAQ guidelines. Federal cost share cannot be more than 80 percent of the total project cost which includes the vehicle base price plus the cost of incremental alternative fuel system, and any fueling or charging infrastructure.

Seven (7) applications totaling \$589,349 in requested funding were received for consideration of \$521,000 in CMAQ funds. The two top ranked applications are recommended for award and are projected to reduce annual criteria pollutants by 338 lbs.

Accessing Oklahoma Department of Transportation (ODOT) Database Records

#### INFORMATION:

The database of records for certain pieces of information that ACOG member entities need and must have to fill out their TIP applications is maintained by ODOT, and the information is ultimately required by ODOT on the forms; however, when this information has been requested by ACOG members for this year, ODOT has required members to fill out an Open Records request. This is unduly burdensome.

Therefore, specific direction is needed to instruct the Executive Director to authorize ACOG members for them to be able to access 0D0T database records without an Open Records request when preparing TIP applications.
