A. CALL TO ORDER

Chairman John M. Sharp called the meeting to order at 10 a.m. He introduced himself and entertained introductions of members, staff, and guests. There was a quorum.

B. APPROVAL OF THE OCTOBER 15, 2020 MINUTES

David Riesland moved to approve the October 15, 2020 minutes. Lakesha Dunbar seconded the motion. The motion carried unanimously.

C. APPROVAL OF ACTION ITEMS:

1. Final 2045 OCARTS Employment Projections by County and City

John Sharp said these are the final 2045 OCARTS employment projections by county and city that ACOG collected from Woods and Poole and trend data (past employment in the OCARTS area projected forward to 2045). Based on the discussion in the Areawide Planning and Technical Advisory Committee (APTAC) meeting, Table 1 will be skipped at this meeting. He added that Table 2 shows the final 2045 county and city employment totals.

Mr. Sharp said the table shows the 2015 base employment, approved earlier this year, as well as the 2040 Plan numbers. The comment field on the right side explains the source of the 2045 information. In some cases, the information is the same as the 2040 Plan. In others, an average was developed, which was an average between the 2040 Plan and 2045 trend numbers. There were also Woods and Poole numbers recommended, and staff members talked to local staff to make modifications to the table.

Mr. Sharp said there has been employment growth from about 875,000 for 2040 up to about 971,000 for 2045. Obviously, ACOG modeling staff will watch some of the recent trends with people working from home.

David Riesland moved to recommend that the ITPC approve the final 2045 OCARTS county and city employment projections. Jerry Ihler seconded the motion. The motion carried unanimously.

2. ITTC Meeting Schedule for 2021

John Sharp said generally, the ITTC has 11 meetings throughout the year, with no meeting in July. He said the agenda packet that was sent out to them might list December 2 as the meeting date, but it needs to be corrected to say December 9 to give ACOG staff enough time to complete the agendas following the Thanksgiving holiday. Also, the November meeting has been scheduled for Wednesday, November 10, since Thursday, November 11, is Veteran's Day.

Commissioner Rod Cleveland moved to recommend that the ITPC approve the proposed 2021 ITTC meeting schedule with the December 9 correction. Joyce Green seconded the motion. The motion carried unanimously.

D. ITEMS FOR INFORMATION ONLY:

1. Norman Traffic Management Center

David Riesland gave a presentation about the Norman Traffic Management Center (TMC). Mr. Riesland said for those who may not know, a TMC in Norman was Angelo Lombardo's vision shortly after coming to work for the city 28 years ago and about two years ago, that opportunity presented itself. The Norman Police Department began to spearhead an effort to build a new Emergency Operations Center (EOC), and in that EOC, Mr. Lombardo saw an opportunity for that vision to become a reality.

Mr. Riesland said this project kicked off towards the end of 2019 with a request for proposals and two qualified firms responded. The decision was made to go with Stantec/ESG. ESG was part of the Stantec team because they have local offices and can be the local liaison. He said shortly after their kickoff meeting on February 11, 2020, we entered quarantine for COVID-19, so the stakeholder and coordination meetings with the Stantec team were all done virtually.

Mr. Riesland said Stantec's process has followed all the FHWA criterion for systems engineering analysis, including the V diagram as part of that. He showed the V diagram that was actually part of the Concept of Operations portion of the report that was presented to FHWA in October, showing the different steps to go through and it is part of any systems engineering analysis for a TMC.

Mr. Riesland said the Concept of Operations document helps to map the project ITS architecture with the system requirements. He said it is very important to have it fit in with the plans of ACOG and ODOT and it speaks to what might need to be updated in both of those plans in order to have everything be cohesive.

Mr. Riesland said this is one of the 20 projects that Norman submitted in the FFY 2022-2025 TIP Call for Projects, and currently they are looking at a couple of options for TMC locations. As the EOC project evolved, it became increasingly obvious that it was going to be over budget. Staff had to finish the EOC with the funds they had available and not try to seek additional funds. He said that meant the TMC had 268 square feet carved out for a space for operators and video screens with a very small office attached, that was not going to be big enough to be effective. It was only going to provide space for two operators, but staff felt they needed three.

In working with Stantec, they took the wall out between the office and the Operations Center to allow that third space, and they are designating this as the emergency TMC. He said if there is something that happens in Norman, and someone, whether it be the mayor or a member of council, that is at the EOC would need to see something, they could have operators at this location to show them whatever they needed to show.

Mr. Riesland said while they were trying to figure out what to do with the EOC space, another opportunity presented itself. Just to the north of their Traffic Division office is the sanitation building. Norman has plans to construct a new sanitation building and this building will become available. In their capital request, this project or this building would go to Public Works; whether that is traffic or fleet, they are not sure yet. However, they are trying to get it to where it could be a future site of the full-time TMC. This building is a little over 3,000 square feet and would make an excellent alternative to what was being proposed in the EOC. They are very hopeful that the funding that has been identified in their requests will actually fill out both spaces, and that is where they are now.

Mr. Sharp said this type of project presents many challenges, but the positive side of this is the coordination between the EOC members. He said Edmond has a TMC as well and it allows them to coordinate really well with ODOT at the exit ramp at Second Street. In fact, Edmond assists ODOT in getting people off that ramp as Edmond controls the light at the top of the Second Street ramp, and the same issue there would be true in Norman, where there are a lot of exit ramps off of I-35. This can be challenging on game days and with major events. If they can control the lights next to those ramps, it can alleviate some of that congestion in the area.

Mr. Sharp said going forward, more of these EOCs will be seen. However, there are challenges with budgets and space to get these facilities planned, along with the IT challenges of getting all the fiber and the cable organized in order to coordinate with everybody and be available at all times.

Mr. Sharp said it is not just the City of Norman on this project; as the memo stated there are other partners that are involved in this discussion. He said that was very important from the start, because there are partners who can be involved in this discussion, including OU, OU PD, Fire Departments, Norman schools, and Cleveland County from the standpoint of coordinating for major events.

2. 2020-2021 OCARTS Area Regional Snow Routes

Jennifer Sebesta thanked the committee for participating in this process, saying ACOG did not receive any updates this year. She referred to a link in the agenda to the new map as it has different graphics; not routes. She said to please feel free to share the map with their emergency managers, their public information directors, and their social media accounts to get the information out to as many people as possible.

Mr. Sharp said ACOG does not usually move this fast, but usually does not have an ice storm in October either, so this map was pushed out as quickly as possible due to the slick roads at the end of October.

Mr. Sharp noted that they probably saw along the way, during the ice storm, that some of the four lane roads became two lane roads as trees fell in the outside lane. Going forward, our region will need to keep an eye on that also from a safety standpoint. Ms. Sebesta mentioned that if they do end up having route changes throughout the winter, to please let ACOG know so the map can be updated and sent out again to everyone.

3. 2021 Oklahoma Recreational Trails Grant Program - Applications Due January 29, 2021

Hannah Nolen said this is a funding opportunity ACOG wanted to bring to the committee. She said it is a reimbursable grant that can cover 80 percent of the cost for trails projects. Ms. Nolen said the deadline for applications is the end of January. ACOG is bringing this to the committee now because part of the application process requires a public hearing. She said if they have any questions, to contact Susan Henry with the Oklahoma Tourism and Recreation Department.

4. Ozone Season 2020 Update

Eric Pollard gave a quick update now that our region is at the close of ozone season for 2020. He was happy to report that the region had a very mild summer and only registered two exceedances. Both were at the Oklahoma City north monitor, located at Oklahoma Christian University on Memorial Road in Edmond. He said there was only one ozone alert day called, which happened in October, which was pretty strange.

Mr. Pollard said a number of factors are being looked at, and ACOG is waiting for a full report from the Oklahoma Department of Environmental Quality, probably later next month or in January, about what they saw in terms of the ozone season. ACOG is taking the mild summer weather, combined with potentially the lower VMT related to the pandemic, plus even potentially, the decreased oil and gas activity in the scoop and stack area on the western side of our region which may have all contributed, but ACOG will wait to hear from ODEQ and report back on their findings.

Mr. Pollard said one thing to keep in mind is the current administration has as their goal to have a standard in place on the EPA ozone rule by the end of the calendar year or in January and obviously, if it does not happen, ACOG will need to monitor what the next administration does in terms of the ozone rule. It probably will not be lowered, but it is always a possibility. He said our region is always one bad season away from violating the standard, and so will remain diligent on both through our Cost of Nonattainment Study and our Ozone Advance Report that is done in conjunction with all of our communities just to stay on top of reducing emissions.

Mr. Pollard asked the committee to take a look at the Ozone Advance Report that was submitted earlier this year. He said if there are any projects they see that are missing, or if they want to model any of the products that are in there to their own communities, it can be reviewed for that as well.

5. OCARTS Area Line Item Projects and Administrative Modifications

Lauren Wood said this is a monthly update to the line items and administration modifications from ODOT on active projects in the OCARTS area. She said for FFY 2021, this month there were two line items added, but no administrative modifications. Mr. Sharp said if anyone has comments or if there are updates from ODOT, to please let ACOG know.

6. Status of Surface Transportation Block Grant-Urbanized Area (STBG-UZA), Transportation Alternatives Program (TAP), and Transportation Enhancement (TE) Projects in the OCARTS Transportation Management Area (TMA)

Chairman Sharp said these are the STBG-UZA, TAP, and TE projects in the OCARTS TMA with updated information from ODOT.

E. NEW BUSINESS

Mr. Sharp asked if there was any new business to be brought forth to the committee.

Electric Vehicles - Potential Road Use Charge

Eric Pollard said there is a policy issue that ACOG has been following over the last few years. There have been quite a number of discussions at the legislature about electric vehicles paying a road use fee since electric vehicle owners do not buy gasoline. He said it will impact us increasingly moving forward when it comes to revenue from the gas tax. In

fact, he said when reviewing the 2045 ODOT long range plan, it has a lot of good numbers about how serious that issue will become as the fleets continue to become more fuel efficient, so it is not just an electric vehicle issue, as our gasoline powered vehicles are getting more efficient as well.

Mr. Pollard said those discussions about electric vehicle road use fees will continue. This legislative session, there is some talk of a flat annual fee of somewhere between \$120-\$160, which is about what gasoline drivers pay, although it is not a perfectly equitable thing as some EV drivers may just drive to church once a week, versus somebody that is commuting to work and driving kids around.

Mr. Pollard said there is a potential that the legislature will look at a VMT or a Road Use Charge Pilot in partnership with ODOT and ACOG. This VMT charge project has been done in Utah and Oregon, as well as on the East Coast. EV users would pay a fee based on the mileage they drive per year. He said this is something that would need future legislation. ACOG is working with a number of groups to investigate the potential of doing that. If so, it will probably need a 2- or 3-year study to become statistically significant.

Meeting Changes

Mr. Sharp said there will be some changes on November 15 that will affect the ability for ACOG to have virtual meetings. The law states after November 15, there cannot be a virtual meeting where voting can take place virtually. ACOG will let the committee know how the meetings will be handled.

Transit agencies and sub-recipients of transit funding in the OCARTS area meet on a quarterly basis throughout the region to stay up to date on new services, changes, and issues in both the current and upcoming quarter. Representatives from Citylink, City of Norman, COTPA, ODOT, Oklahoma City Planning Department, and ACOG participated in a virtual meeting on December 2, 2020. Below is a brief summary of what was discussed.

- Shelby Templin with ODOT's Strategic Asset and Performance Management Division provided an overview and update on the Oklahoma Public Transit Policy Plan.
- Citylink's University of Central Oklahoma (UCO) Broncholink ridership remains high despite drops in other fixed-routes' ridership and the City of Edmond continues work on their long-range plan update.
- COTPA's Northwest Bus Rapid Transit project recently completed the first draft of preliminary 30 percent design reports and continues to coordinate with property owners located along the alignment regarding station locations, access, and right-ofway.
- ODOT's Office of Mobility and Public Transit continues to operate the state's 5310 program and have recently completed their first Call for Projects.
- Oklahoma City Planning Department continues to work with ACOG on a regional bicycle and pedestrian safety awareness campaign.
- City of Norman is working with a consultant to update the city's long-range transit plan. The final plan is expected to be complete in June 2021.

INFORMATION:

To ensure that the OCARTS Area Transportation Improvement Program (TIP) will remain financially constrained, an estimated apportionment of STBG-UZA funds for the Oklahoma City Urbanized Area has been developed in consultation with the Programs Division of the Oklahoma Department of Transportation (ODOT). The figures below reflect the estimated STBG-UZA apportionment that will be received in FFY 2022 and FFY 2023.

In August 2020, the Intermodal Transportation Policy Committee (ITPC) voted to implement a rolling two-year lock of projects. As a result, two years' worth of projects, FFY 2022 and 2023, will be selected at the January 14, 2021 ITTC meeting. The latter two unlocked years will be listed in order of score and will be updated during the next project selection process in January 2022.

As required by the FAST Act, a year-of-expenditure inflation factor is also being applied to the project cost estimates submitted by the project sponsors. Inflation factors of 3 and 6 percent will be used for FFY 2022 and 2023, respectively.

ACOG's STBG Procedures for the OCARTS Area Urbanized Area Funds calls for 90 percent of the estimated apportionment to be used in preparing the TIP. This is intended to avoid a shortage of funds in case the actual STBG-UZA funds are less than the estimate used to develop the TIP. Also, federal rules allow 10 percent of the estimated STBG distribution to be used to finance 100 percent of the construction of eligible safety projects.

Below are the estimated annual STBG-UZA (80 percent federal) and STBG-UZA Safety (100 percent federal) funds to be used to develop the FFY 2022-2025 OCARTS Area TIP.

INFORMATION:

On October 1, 2020 the Association of Central Oklahoma Governments (ACOG) issued its FY 2021 Public Fleet CLEAN AIR Grants Call for Projects.

Congestion Mitigation and Air Quality (CMAQ) funds assigned to the Oklahoma City Area Regional Transportation Study (OCARTS) area provide the resources for these competitive grant awards. Eligible projects include fleet conversion to clean fuel technologies, the acquisition of alternative fuel or hybrid vehicles, and/or the purchase and installation of alternative fuel vehicle refueling or recharging infrastructure.

Eligible entities include: OCARTS local government member entities, OCARTS member public transit fleets, public trusts and public authorities that provide essential services to OCARTS member entities, public colleges and universities, Oklahoma Career Tech System Technology Centers lying principally within the OCARTS boundary, public school districts lying principally within the OCARTS boundary, and Public-Private Partnerships (PPPs). For example, private sector entities that contract services such as refuse hauling or school transportation or the establishment of alternative fueling station operations and maintenance to eligible OCARTS-area public entities.

Only the incremental cost of a vehicle's alternative fuel system can be considered for funding under CMAQ guidelines. Federal cost share cannot be more than 80 percent of the total project cost which includes the vehicle base price plus the cost of incremental alternative fuel system, and any fueling or charging infrastructure. The grant defrays either the incremental cost of an alternative fuel vehicle and/or up to 80 percent of the cost of fueling and charging infrastructure equipment.

Four (4) applications totaling \$250,712 were received for consideration of the \$350,000 in CMAQ funds. The following projects are recommended for award and are projected to reduce criteria pollutants by 326.20 lbs. annually.

INFORMATION:

The FY 2021 Air Quality Small Grant Program Call for Projects was held from October 2 to November 6, 2020. This grant program strives to improve air quality in Central Oklahoma by funding small infrastructure projects and congestion relief efforts. With \$200,000 available in Congestion Mitigation and Air Quality (CMAQ) funds for this year, ACOG received one application requesting a total of \$163,857.60

The City of Oklahoma City is requesting funds to create bicycle lanes along N. Lottie Ave. from NE 4th St. to NE 23rd St., with connections to Kelley Ave. Vertical delineators will be used along the N. Lottie Ave. route to provide protection to bicyclists. Shared lanes are proposed along Madison St. from N. Lottie Ave. to N. Kelley Ave.

The City's application was reviewed and scored by a committee consisting of representatives from ODOT, the Oklahoma City Community Foundation, and ACOG staff.

The 2020 Air Quality Small Grant Program Application Guidebook states that no single entity can receive more than 56 percent of the total available CMAQ funding, unless there are not enough projects proposed, as was the case this year. As the sole applicant of a high-scoring project proposal, ACOG recommends Oklahoma City's project for funding.
