#### A. CALL TO ORDER

Chairperson Steven Gentling called the meeting to order at 1:45 p.m. A quorum was present. He welcomed all in attendance.

#### B. APPROVAL OF THE OCTOBER 28, 2021, MINUTES

Councilmember Gene Reid moved to approve the October 28, 2021, minutes. Commissioner Marc Hader seconded the motion. The motion carried unanimously.

#### D. REGULAR AGENDA ITEMS THAT MAY REQUIRE ITPC ACTION

1. **Public Hearing and Action** on Request for Amendment of the FFY 2022-2025 Transportation Improvement Program (TIP) by the City of Oklahoma City

Jennifer Sebesta highlighted the information provided in the agenda memorandum regarding Oklahoma City's request for amendment to the FFY 2022-2025 TIP.

Chairperson Steven Gentling opened the public hearing. There being no response from the public, the public hearing was closed.

Mayor Matt Dukes made a motion to amend the FFY 2022 of the FY 2022-2025 TIP to change the scope of the S.E. 59<sup>th</sup> St. Bike/Ped & Resurfacing Project in the City of Oklahoma City and submit the same Oklahoma Department of Transportation (ODOT) for amendment of the Statewide Transportation Improvement Program (STIP). Councilmember Chad Williams seconded the motion. The motion carried unanimously.

2. Benefit-Cost Analysis of Encompass 2045 Transportation Alternate Networks

Jennifer Sebesta highlighted the information provided in the agenda memorandum. Ms. Sebesta said the analysis compares the benefits and costs associated with each alternative network and determines if the suggested improvements are representative of sound investment decisions.

#### 3. Encompass 2045 Public Outreach

Hannah Nolen said ACOG developed an Encompass 2045 Public Outreach Plan which details the public engagement strategies that were employed during the development and promotion of the Encompass 2045 Metropolitan Transportation Plan. Ms. Nolen gave an overview of the current status of Encompass 2045 public outreach. The presentation can be viewed here: <a href="https://www.acogok.org/wp-content/uploads/2021/11/Encompass-2045-Public-Outreach-ITPC.pdf">https://www.acogok.org/wp-content/uploads/2021/11/Encompass-2045-Public-Outreach-ITPC.pdf</a>. Ms. Nolen encouraged the committee to follow the associated social media accounts, as well as ACOG's website, for more information.

Ms. Nolen said as part of the planning process, ACOG conducted two public surveys. The first public survey published last year received 513 responses. The second public survey was open from October 11 through November 15, 2021. ACOG received 281 responses but 100 of those were outside of the MPO area. Chairperson Steven Gentling asked the reason for the drop in responses from the first survey to the second. Ms. Nolen said a variety of reasons, such as lack of interest, could be to blame.

Chairperson Steven Gentling asked Ms. Nolen how members of this committee could help ACOG get better results from the survey. Councilmember Todd Stone suggested sending the survey to registered voters. Commissioner Rod Cleveland said there are digital internet tools to target registered voters, but there is a cost.

4. **Public Hearing and Action** on Encompass 2045 Metropolitan Transportation Plan Jennifer Sebesta highlighted the information provided in the agenda memorandum.

Chairperson Steven Gentling opened the public hearing. There being no response from the public, the public hearing was closed.

Mayor Matt Dukes moved to approve the proposed financially constrained Encompass 2045 Metropolitan Transportation Plan. Councilmember Mark Hamm seconded the motion. The motion carried unanimously.

5. ITPC Meeting Schedule for 2022

John Sharp presented the proposed 2022 meeting schedules for APTAC, BPAC, ITTC, AQAC, and COKCC.

Mayor Matt Dukes moved to approve the proposed 2022 APTAC, BPAC, ITTC, ITPC, AQAC, and COKCC meeting schedules. Commissioner Marc Hader seconded the motion. The motion carried unanimously.

6. Oklahoma City Area Regional Transportation Study (OCARTS)

John Sharp said the name 'Oklahoma City Area Regional Transportation Study' or 'OCARTS' had originally been used to describe the first metro transportation study in 1968. The term was coined by a consultant and has not been updated since that time. Mr. Sharp said ACOG staff recommended to transition from using the dated terminology of OCARTS, which included 'study' in its name, to a more descriptive title for the MPO service area.

Staff presented five choices and ACOG MPO was the name chosen.

Mayor Matt Dukes moved to approve the replacement of OCARTS with ACOG MPO as the official MPO boundary area name. Mayor Breea Clark seconded the motion. The motion carried unanimously.

#### 7. Infrastructure Bill Overview

John Sharp gave an overview of the \$1.2 trillion infrastructure bill that was signed on Friday, November 5, 2021. The bill will provide funding through federal fiscal year (FFY) 2026. Approximately \$568 million will be received by the U.S. Department of Transportation. Mr. Sharp highlighted what the major funding package included.

#### 8. Transportation News and Update Report

John Sharp presented the following transportation news and updates:

#### Encompass 2045

ACOG hosted the last Encompass 2045 Plan public outreach meeting this month.

#### Harrah Technical Assistance

Mr. Sharp said ACOG staff assisted the City of Harrah with zoning, mapping, and addressing.

#### **Trail Coordination Meeting**

ACOG hosted a meeting for a possible trail linkage between Oklahoma City, Del City, Midwest City, and Tinker Air Force Base.

#### Watch for Me OK Campaign

The campaign will be running a commercial on KFOR (channel 4) from Thanksgiving until Christmas. This is being paid for by the Oklahoma Highway Safety Office Grant that ACOG received.

#### **Edmond Mobility Fair**

Mr. Sharp said ACOG staff participated in the event to gather public feedback on all forms of transportation in the community.

#### **Aerial Flights**

Mr. Sharp said ACOG is currently coordinating with local communities for next year's aerial flight. There are currently six communities participating in the project and ACOG will be working on collecting aerial photographs of these communities in February or March 2022.

#### Air Quality

Mr. Sharp said ACOG is providing technical support to the Oklahoma Corporation Commission regarding electric vehicle charging stations. The Hydrogen Task Force report will be completed soon. Also, ACOG is in discussion with the Federal Highway Administration (FHWA) and Oklahoma Department of Transportation (ODOT) on planning for future alternative fuel corridors.

#### E. NEW BUSINESS

Chairperson Steven Gentling asked if there was any new business to present. No new business was presented.

There being no further business, Chairperson Steven Gentling adjourned the meeting at 3:05 p.m.

#### **INFORMATION:**

As part of the COVID-19 relief funding, the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) provided \$10 billion for transportation nationwide. The apportionment for the ACOG MPO is \$8,980,567 (see attached letter). These funds can be used for projects that are eligible for Surface Transportation Block Grant (STBG) program funding. The funding is available for obligation until September 30, 2024. Most importantly, these funds are 100 percent federal share, hence no local match is required.

Staff recommends that a workgroup be created to discuss how this funding can be distributed in an equitable way to the membership. Coordination with ODOT staff is important and their suggestions should be considered, as this funding could lead to a large number of projects.

#### **INFORMATION:**

On October 4, 2021, the Association of Central Oklahoma Governments (ACOG) issued its FY 2022 Public Fleet CLEAN AIR Grants Call for Projects.

Congestion Mitigation and Air Quality (CMAQ) funds assigned to the ACOG MPO area provide the resources for these competitive grant awards. Eligible projects include fleet conversion to clean fuel technologies, the acquisition of alternative fuel or hybrid vehicles, and/or the purchase and installation of alternative fuel vehicle refueling or recharging infrastructure.

Eligible entities include: ACOG MPO local government member entities, member public transit fleets, public trusts and public authorities that provide essential services to member entities, public colleges and universities, Oklahoma Career Tech System Technology Centers, public school districts, and Public-Private Partnerships (PPPs). For example, private sector entities that contract services such as refuse hauling or school transportation or the establishment of alternative fueling station operations and maintenance to eligible area public entities.

Only the incremental cost of a vehicle's alternative fuel system can be considered for funding under CMAQ guidelines. Federal cost share cannot be more than 80 percent of the total project cost, which includes the vehicle base price plus the cost of incremental alternative fuel system, and any fueling or charging infrastructure. The grant defrays either the incremental cost of an alternative fuel vehicle and/or up to 80 percent of the cost of fueling and charging infrastructure equipment.

Four (4) applications totaling \$527,489 were received for consideration of the \$550,000 in CMAQ funds. The following projects are recommended for award and are projected to reduce criteria pollutants by 224 lbs. annually.

#### **INFORMATION:**

The FY 2022 funding cycle of ACOG's Air Quality Small Grant Program closed Friday, November 19, 2021. The program sets out to fund air-quality related small transportation infrastructure projects and congestion relief efforts. With \$400,000 available via Congestion Mitigation and Air Quality (CMAQ) funds, ACOG received ten applications requesting a total of \$921,874.

Applications were reviewed and scored by a committee consisting of ACOG staff and representatives from the Oklahoma Department of Transportation (ODOT), the Oklahoma Department of Environmental Quality (ODEQ), and the Oklahoma City Community Foundation (OCCF).

Projects selected for funding can be found in the table on the following page. The top four scoring projects are recommended to be funded in full, at a total of \$364,241. ACOG recommends that the remaining \$35,759 be allocated to the next highest scoring project, Adair Blvd. Active Transportation Improvements in Midwest City, for partial funding. If approved by the ACOG MPO Policy Committee, \$22,511 in CMAQ funding from the Public Fleet Grant Program will be awarded to this project as well, bringing the project award amount to \$58,270 and the total program award amount to \$422,511. Any additional funding that becomes available, such as residual from the Public Fleet Grant, should be made available to the Adair Blvd. project and/or the next highest scoring backup project.

Motion to approve funding for the FY 2022 Air Quality Small Grant Program project list (\$364,241) and allocate any remaining funds (\$58,270) to the next highest scoring project(s), for a total of \$422,511 in funding.

#### **INFORMATION:**

The Oklahoma Department of Transportation (ODOT), in compliance with Title 23 of the United States Code (U.S.C.), has requested approval from the Federal Highway Administration (FHWA) to designate an urban interstate loop in the Oklahoma City metropolitan area (see attached letter and map for additional details).

The proposed loop, which was approved by the Oklahoma Transportation Commission on August 2, 2021, would be designated as I-240 and contain the following routes:

- 4.8 mile stretch of roadway, currently known as SH-152, beginning at the intersection of I-44 and SH-152 and going west to the intersection of SH-152 and the John Kilpatrick Turnpike.
- 30.97 mile stretch of roadway, known as the John Kilpatrick Turnpike, beginning at the intersection of SH-152 and the John Kilpatrick Turnpike going north and east to the intersection of the John Kilpatrick Turnpike and I-35/I-44/Turner Turnpike.
- 18.71 mile stretch of roadway, known as the Kickapoo Turnpike, beginning at the intersection of Kickapoo Turnpike and I-44/Turner Turnpike and going south to the intersection of the Kickapoo Turnpike and I-40.
- 1.4 mile stretch of roadway, known as I-44, beginning at the intersection of I-240 and I-44 and going north to the intersection of I-44 and SH-152. The I-240 Follow Route Designation will be secondary to the primary I-44 designation.
- 13.7 mile stretch of roadway, known as I-44/Turner Turnpike, beginning at the intersection of John Kilpatrick Turnpike and I-35/I-44/Turner Turnpike and going northeast to the intersection of I-44/Turner Turnpike and the Kickapoo Turnpike. The I-240 Follow Route Designation will be secondary to the primary I-44 designation.
- 5.81 mile stretch of roadway, known as I-40, beginning at the intersection of I-40 and the Kickapoo Turnpike and going west to the intersection of I-40 and I-240. The I-240 Follow Route Designation will be secondary to the primary I-40 designation.

This change would provide the traveling public with a designated loop around the metro area. An ODOT representative will be at the January meeting to discuss the proposed designation and answer any questions.

In compliance with the Title 23 of the United States Code (U.S.C.), the Oklahoma Department of Transportation (ODOT) is requesting Federal Highway Administration (FHWA) approval of the designation of an urban interstate loop in the Greater Oklahoma City Area that will be called I-240.

For designation as a part of the Interstate system, 23 U.S.C. 103(c)(4)(A) requires that a highway meet all the standards of a highway on the Interstate System, be a logical addition or connection to the Interstate System, and have the affirmative recommendation of the State or States involved. ODOT affirms that these conditions have been met.

The Code of Federal Regulations (CFR) 470.111(a) states that proposals for system actions on the Interstate System shall include a route description and a statement of justification. Proposals shall also include statements regarding coordination with adjoining States on Stateline connections, with responsible local officials, and with officials of areas under Federal jurisdiction.

The route is described as follows and a map showing the route is included as an attachment.

- A 4.8 mile stretch of roadway, currently known as SH-152, beginning at the intersection
  of I-44 and SH-152 and going west to the intersection of SH-152 and the John Kilpatrick
  Turnpike.
- A 30.97 mile stretch of roadway, known as the John Kilpatrick Turnpike, beginning at the intersection of SH-152 and the John Kilpatrick Turnpike going north and east to the intersection of the John Kilpatrick Turnpike and I-35\I-44\Turner Turnpike.
- A 18.71 mile stretch of roadway, known as the Kickapoo Turnpike, beginning at the intersection of Kickapoo Turnpike and I-44\Turner Turnpike and going south to the intersection of the Kickapoo Turnpike and I-40.

- A 1.4 mile stretch of roadway, known as I-44, beginning at the intersection of I-240 and I-44 and going north to the intersection of I-44 and SH-152. The I-240 Follow Route Designation will be secondary to the primary I-44 designation.
- A 13.7 mile stretch of roadway, known as I-44\Turner Turnpike, beginning at the
  intersection of John Kilpatrick Turnpike and I-35\I-44\Turner Turnpike and going
  northeast to the intersection of I-44\Turner Turnpike and the Kickapoo Turnpike. The I240 Follow Route Designation will be secondary to the primary I-44 designation.
- A 5.81 mile stretch of roadway, known as I-40, beginning at the intersection of I-40 and the Kickapoo Turnpike and going west to the intersection of I-40 and I-240. The I-240 Follow Route Designation will be secondary to the primary I-40 designation.

This designation is needed to give the traveling public a more definitive loop to follow around the Greater Oklahoma City Area and to better identify the un-numbered Turnpikes in the City of Oklahoma City.

The I-240 designation was approved by the Oklahoma Transportation Commission on August 2, 2021.

CFR 470.111(d) states that proposals for Interstate route numbering shall be submitted by the State transportation agency to the Route Numbering Committee of the American Association of State Highway and Transportation Officials (AASHTO). This request will also be presented AASHTO Route Numbering Committee at the next AASHTO Annual Meeting in October 2021.
