Chairperson Steven Gentling called the meeting to order at 1:45 p.m. A quorum was present. He welcomed all in attendance.

B. APPROVAL OF THE NOVEMBER 18, 2021, MINUTES

Mayor Peter Hoffman moved to approve the November 18, 2021, minutes. Mayor Ray Poland seconded the motion. The motion carried unanimously.

Mayor Ray Poland moved to approve that all items under the Consent Docket be considered in one vote. Mayor Breea Clark seconded the motion. The motion carried unanimously.

D. REGULAR AGENDA ITEMS THAT MAY REQUIRE ITPC ACTION

1. Selection of FY 2022 ACOG Public Fleet CLEAN AIR Grants Projects

Eric Pollard highlighted the information provided in the agenda memorandum. Mayor Peter Hoffman thanked Mr. Pollard and the ACOG team for the work they did helping Nichols Hills with replacing gasoline powered police cars with electrical vehicles.

It was suggested by the committee to have Mayor Hoffman give a critique in six months on the electric police vehicles. Mayor Hoffman agreed to come and give an update.

Mayor Ray Poland moved to approve the four projects listed for funding (\$527,489), utilizing CMAQ funds allocated to ACOG's Public Fleet Conversion Grant (CLEAN AIR Grants) Program, and move the remaining funds (\$22,511) to the Air Quality Small Grant Program. Councilmember Josh Moore seconded. The motion carried unanimously.

2. Air Quality Small Grant Program Selection

Jennifer Sebesta highlighted the information provided in the agenda memorandum. Ms. Sebesta said ACOG received 10 applications requesting a total of \$921,874. The applications were reviewed with the help of a scoring committee and the projects listed in the agenda are being recommended for funding.

Councilmember Josh Moore moved to approve the funding for the FY 2022 Air Quality Small Grant Program project list and allocate any remaining funds (\$58,270 plus \$22,511 from the Public Fleet Program) to the next highest scoring project for a total of \$422,511 in funding. Mayor Ray Poland seconded. The motion carried unanimously.

3. Proposed I-240 Loop

Matt Swift with the Oklahoma Department of Transportation (ODOT) highlighted the information provided in the agenda. Mr. Swift said this is a signage request to designate an urban interstate loop (I-240) in the Oklahoma City metropolitan area. He said that as soon as ODOT receives FHWA's written approval, they will begin the process of installing signage. Mr. Swift added that the State Highway map will show this loop as I-240 and said that any route which shows dual designation, there will be one predominant route. For example, on the northeast side where you have both I-44 and I-240, the main route will be I-44 and I-240 will be added as a follow (secondary) route.

4. Transportation News and Update Report

John Sharp presented the following transportation news and updates:

Corona Virus Responses and Relief Supplemental Appropriations Act (CRRSAA) John Sharp addressed the Corona Virus Response and Relief Supplemental Appropriations Act (CRRSAA) funding, saying that ACOG hosted the first workgroup meeting to discuss options this month. This appropriation provides \$8.9 million in funding, and it is 100 percent money, meaning there is no local match required. Mr. Sharp said the funds must be obligated by 2024 and the money spent by the fall of 2029. ACOG would like to make this funding available to all ACOG MPO members, but there are a few restrictions as the funding is tied to the functional classification system, just like Surface Transportation Block Grant (STBG) funding.

Mayor Gentling said he feels the money is tailored made for small towns, and he cautioned the members to be thinking about ways their community could use the money.

Cost of Nonattainment Study

John Sharp said ACOG is finishing up the Cost of Nonattainment Study report that is 139 pages and it is a very technical report. Mr. Sharp said the plan is to have it available in February.

Watch For Me Safety Campaign

ACOG has a public service announcement (PSA) airing between the Thanksgiving and Christmas holidays. It was paid for by a grant from the Oklahoma Highway Safety Office (OHSO).

Surface Transportation Block Grant Projects

John Sharp said the projects for this grant will be finalized in February. ACOG will be recommending funding for selected projects.

I-35 Corridor Study

Mr. Sharp said ACOG staff continues to work with ODOT and EST on the corridor project.

Statewide Travel Demand Model

John Sharp said this is the first time a statewide model has been developed by ODOT. ACOG staff was recently given an overview of the model.

Infrastructure Bill

Mr. Sharp said ACOG staff is preparing for a meeting with ODOT staff next week to discuss the new infrastructure bill and transportation funding. He said there are changes from past bills, granting more flexibility for ODOT.

Road User Pilot Program

John Sharp said ACOG staff is assisting Secretary Gatz and ODOT staff with the preliminary research on the program. Mr. Sharp said legislation was passed last year to look into the road user program.

Future Transportation Options

ACOG staff met with Goldsby staff and the mayor to discuss transportation options and projects.

Tinker Air Force Base

John Sharp said in February, ACOG staff will be assisting Tinker AFB with their transportation plan update.

Tree Canopy Study

John Sharp said ACOG is working with the Oklahoma City Community Foundation (OCCF) and the Oklahoma Forestry Service to discuss further utilization of the data that was collected by the Tree Canopy Study.

2022 Aerial Flight

Mr. Sharp said ACOG is close to finalizing the company that will be flying the 2022 aerial flight. The cities included in this group buy are Blanchard, Choctaw, Edmond, Moore, Oklahoma City, and Yukon.

Oklahoma Turnpike

John Sharp said there is news of a turnpike on the southeast side of the metro. He has not seen a map but there is ongoing discussion. ACOG will provide more information when it is available.

INFORMATION:

On November 15, 2021, the Federal Infrastructure Investment and Jobs Act (IIJA) was signed into law. This bill increases the amount of Transportation Alternatives Program (TAP) funding for states and Metropolitan Planning Organizations by nearly 70 percent over a 5-year period. In anticipation of receiving these funds, ACOG has begun reevaluating the TAP criteria from the 2017 Call for Projects.

Staff sent a survey on January 5, 2022, to BPAC and ACOG MPO Technical Committee (formerly ITTC) members to gather feedback and suggestions on the current scoring criteria. Jordan Evans gave a presentation at the February ACOG MPO Technical Committee meeting on the survey results and ACOG staff's recommendations for the upcoming Call for Projects. INFORMATION:

ACOG staff has begun preparing the CY 2021 Network Monitoring Report, as called for by the Unified Planning Work Program. The purpose of this report is to maintain current information on the implementation of multimodal transportation improvements in the ACOG MPO area in conformance with the goals of the Metropolitan Transportation Plan, as well as to update the regional transportation model. The report will identify all projects completed in 2021 resulting in increased transportation choices, improved traffic flow, and/or increased street/highway network capacities in the region. INFORMATION:

Performance-based planning and programming continues to be a national emphasis per federal transportation legislation. Federal planning requirements direct metropolitan planning organizations (MPOs) to coordinate with their respective state department of transportation and area public transportation providers in developing 14 performance measures and targets to track and maximize the benefits of transportation planning decisions and infrastructure investments.

Recently, the Oklahoma Department of Transportation (ODOT) submitted the five required safety targets to the Federal Highway Administration (FHWA). Now, ACOG as an MPO, needs to identify and submit regional safety targets for those same five performance measures. Federal guidance states that MPOs may either support the targets of the state or may submit their own targets based on the data from our region. In either instance, ACOG will need to report on the measures and the targets, and eventually explain how the region is making progress towards reaching those targets. This occurs through both ACOG's short-range plan (TIP) and Metropolitan Transportation Plan (MTP). In particular, projects should be selected using criteria which help support the goals, measures, and targets established by the region in the MTP.

A presentation will be given at the March meeting to review possible options for the regional safety targets, as summarized in the attachment, and provide staff recommendations.

The ACOG MPO Technical Committee has recommended approval. Upon approval of the ACOG MPO Policy Committee, the targets will be forwarded to the Oklahoma Department of Transportation (ODOT).
