Jennifer Sebesta highlighted the information provided in the agenda memorandum on the request from City of Norman to amend the FFY 2022 Transit Element of the FFY 2022-2025 TIP.

Chairman Josh Moore opened the public hearing. There being no response from the public, the public hearing was closed.

Mayor Ray Poland made a motion to approve the amendment to FFY 2022-2025 TIP by replacing the City of Norman FFY 2022 Transit Element with the attached program of projects and submit the same to the Oklahoma Department of Transportation (ODOT) for amendment of the Statewide Transportation Improvement Program (STIP). Mayor Shelli Selby seconded the motion. The motion carried unanimously.

3. **Public Hearing and Action** on Request for Amendment to the FFY 2021 Transit Element of the FFY 2020-2023 TIP by the City of Norman.

Jennifer Sebesta highlighted the information provided in the agenda memorandum on the request from the City of Norman for an amendment to the FFY 2021 Transit Element of the FFY 2020-2023 TIP.

Chairman Josh Moore opened the public hearing. There being no response from the public, the public hearing was closed.

Mayor Brian Grider made a motion to amend the FFY 2020-2023 TIP by replacing the City of Norman FFY 2021 Transit Elements with the attached program of projects and submit the same to the Oklahoma Department of Transportation (ODOT) for amendment of the Statewide Transportation Improvement Program (STIP). Mayor Ray Poland seconded the motion. The motion carried unanimously.

4. Safety Performance Measures, Trends, and Targets for CY 2022: Lauren Wood, TPS Associate Planner – Performance

Lauren Wood highlighted the information provided in the agenda memorandum. Ms. Wood said the ACOG MPO Technical Committee has recommended approval. Upon approval of the ACOG Policy Committee, the targets will be forwarded to the Oklahoma Department of Transportation (ODOT).

Mayor Ray Poland made a motion to approve the selected safety targets options and submit the same to ODOT. Councilmember Mark Hamm seconded the motion. The motion carried unanimously.

5. John Sharp presented the following transportation news and updates:

I-35 Corridor Study

Mr. Sharp said ACOG staff continues to provide modeling assistance to ODOT on the proposed improvements to the interchanges and access roads between Norman and Moore.

UPWP Updates

Mr. Sharp said ACOG has received updates for next year's transportation tasks. ACOG is compiling the information and will bring it to the committee at a future meeting.

Oklahoma Turnpike Authority

ACOG met with OTA staff in March to hear updates on their turnpike plans for the metro area.

Road User Charge Committee

Mr. Sharp said ACOG is a part of this committee, coordinated by ODOT, that was created by state legislation last year (HB 1712). Mr. Sharp said ACOG attended the third meeting and one of the agenda items discussed was hiring a consultant to develop and conduct a pilot project. The next meeting is scheduled for May.

Coronavirus Response and Relief Supplemental Appropriations (CRRSAA)

Mr. Sharp said ACOG released a CRRSAA survey to the members to determine their ideas for funding. This is 100% federal funding, so no local match is required. Mr. Sharp said ACOG will be developing a CRRSAA grant manual and application packet over the next few months. ACOG staff have also discussed the option of having a pre-application process, so staff can discuss the projects with the community and ODOT local government staff.

Federal Highway Administration (FHWA)

Mr. Sharp said FHWA just released additional guidance to create safer and more walkable streets.

Ozone Season

ACOG and INCOG are planning a meeting this month with Oklahoma Department of Environmental Quality (ODEQ), and Oklahoma Department of Transportation (ODOT) to discuss ozone season.

Bike/Pedestrian Planning

Mr. Sharp said ACOG hosted a meeting with Oklahoma City and Edmond staff to discuss possible bike and pedestrian linkages/corridors between the two communities. Also, May is Bike Month and there will be a variety of events throughout the month.

Annual Distinguished Service Award

Mr. Sharp said OKC Beautiful hosted their 37th award ceremony this month. ACOG, the Oklahoma City Community Foundation, and the Oklahoma Forestry Services were awarded the President's Special Recognition Award for the Tree Canopy Study for Central Oklahoma.

INFORMATION:

In the FY 2021 Unified Planning Work Program (UPWP), one of the tasks outlined was to update the Commuter Corridors Study and to provide more recent numbers for the Regional Transportation Authority (RTA) of Central Oklahoma. During that year, the responsibility of providing administrative support for the RTA shifted from ACOG to the Central Oklahoma Transportation and Parking Authority (COTPA). So, for this work to be funded, there would have to be a transfer of federal funding to COTPA. The development of a draft Agreement to transfer the funding was completed in February 2022. Meanwhile, the Oklahoma Department of Transportation (ODOT) allowed the planning funds (not used for construction) to be extended into the FY 2022 through a No Cost Time Extension. This allowed the funding to move from one fiscal year into the next.

The following is a list of specific value-added tasks that will be reimbursed by this proposed Agreement:

- Alternatives Analysis on the North/South/East Corridors
- Validated Corridor Mode
- Validated Station Locations
- System Estimate Cost
- Model Ridership Numbers
- Scenario Development

These significant transit related items will be useful in future ACOG Metropolitan Transportation Plan updates. As part of this work, \$560,000 of ACOG's federal Planning Funds are being made available to complete the tasks listed above through an [Agreement between ACOG and COTPA](#). The COTPA Board officially reviewed and approved entering into an Agreement with ACOG, at their March 4, 2022, meeting. As required, COTPA will provide the local match for this project.

Please note that this Agreement begins retroactively on July 1, 2020, and shall terminate on June 30, 2022. All invoices submitted by COTPA for reimbursement must be in compliance with the stipulated tasks as outlined in this Agreement. The ACOG MPO Technical Committee at their April 14 meeting recommended approval of this Agreement.

INFORMATION:

Ozone season typically runs from April to October; however, Central Oklahoma has already seen two exceedances in 2022.

During ozone season, the Association of Central Oklahoma Governments (ACOG) declares 'Ozone Alert Days' when the Oklahoma Department of Environmental Quality (ODEQ) believes ozone pollution levels will be high.

Individuals with respiratory disease (COPD, asthma, emphysema), the elderly, and children with respiratory ailments are all at increased risk of health problems when ozone levels reach unhealthy levels.

ACOG MPO member organizations are invited to join ACOG staff to inform Central Oklahomans of ways they can protect public health and reduce emissions on Ozone Alert Days.

In addition, ACOG, in partnership with ODEQ, submits an ozone pollution mitigation project overview to the Environmental Protection Agency (EPA) for the Ozone Advance program each year. ACOG staff requests assistance from members to identify emissions reductions projects in Central Oklahoma that could be added to the EPA Advance submission.

The purpose of Ozone Advance is to update the EPA on efforts the Oklahoma City Metropolitan Area is making to keep compliant with EPA air quality standards. While participation in the Ozone Advance program does not guarantee that the region would be given any leniency during EPA designations, it provides an opportunity to share what ACOG members and stakeholders are doing to improve regional air quality.
