CENTRAL OKLAHOMA COMPREHENSIVE CLIMATE ACTION PLAN (CCAP) UPDATE

INFORMATION:

In 2023, as part of the Climate Pollution Reduction Grant (CPRG) Program, the Environmental Protection Agency (EPA) issued \$250 million in noncompetitive planning grants to states, local governments, Tribes, and territories to design climate action plans that incorporate measures to reduce greenhouse gas (GHG) emissions in key economic sectors. As the designated grantee for the eight-county Oklahoma City Metropolitan Statistical Area (MSA), ACOG received \$1 million to develop the following:

- A Priority Climate Action Plan (PCAP), a plan identifying a focused list of near-term, high priority, and implementation-ready measures to reduce GHG pollution and an analysis of GHG emissions reductions.
- A Comprehensive Climate Action Plan (CCAP), a plan providing an overview of significant GHG sources and sectors in the Oklahoma City MSA, establishing near-term and long-term GHG emission reduction goals, and providing strategies and identifying measures that address the highest priority sectors to help achieve those goals.

In 2024, the PCAP was completed for the Oklahoma City MSA, identifying fleet and school bus electrification, building decarbonization, and nature-based carbon sequestration as priority GHG reduction measures. These measures will inform the development of the CCAP, which is expected to be completed in late 2025.

CENTRAL OKLAHOMA LONG RANGE TRANSIT PLAN PUBLIC INVOLVEMENT

INFORMATION:

The Association of Central Oklahoma Governments (ACOG), EMBARK, and the City of Oklahoma City MAPS office, in close coordination with other key stakeholders, are developing a Long Range Transit Plan (LRTP) to define recommendations to achieve an integrated regional transit vision for the next 30 years. As the region has continued to grow, there has been a series of planning efforts to identify transformative investments to support the communities of Central Oklahoma. The LRTP will amplify the benefits of these new investments through changes to local services and investments in the transit network.

The LRTP development process is currently entering an evaluation phase, emphasizing outreach to stakeholders, agencies, and the general public. In early 2025, public involvement will include an informational component, including the publishing of a Plan website, factsheets, and ongoing digital communications; as well as an engagement component, including presentations at public meetings, interviews with key agencies and stakeholders, opportunities for public comment, and virtual town halls.

As part of the public involvement process, a Virtual Town Hall will be held Thursday, January 30. to inform the public of the project's vision and intent, present initial findings of the conditions assessment, provide an opportunity for the public to ask questions about the project, and solicit existing community transit needs throughout the ACOG Transportation Management Area (TMA).

Healthy Incentives Grants for Communities - Tobacco Settlement Endowment Trust (TSET)

- Application window opens March 3, 2025, and closes March 28, 2025.
- Award amounts range from \$10,000-\$200,000. No match required.
- Eligible uses may include: walking trails, "farmers gardens, community gardens," market venues, sport courts, bicycle lanes and racks, and consultant services for walkability plans.

- Award amounts up to \$100,000. No match required for communities with populations <10,000.
- Eligible uses may include: plans or studies related to parks, trails, streetscape designs, wayfinding, and increasing access to healthy foods; and construction or implementation of sidewalks, bicycle lanes, trails, wayfinding, traffic calming measures, and park and public space improvements.

Route 66 Revitalization Program - Oklahoma Department of Commerce

- Applications due February 7, 2025.
- Award amounts \$25,000 \$2,000,000. Match is not required, but will strengthen application.
- Program supports historic preservation or economic development projects in communities and counties located along Route 66.
- Eligible uses may include: capital investments, planning and research, and construction or implementation projects (such as placemaking, facility enhancement, or building preservation).
