A regular meeting of the 911 Association of Central Oklahoma Governments (ACOG) Regional Planning & Advisory Committee (RPAC) was convened at 9:30 a.m. Tuesday, June 3, 2025, at ACOG in the Oklahoma Board Room, 4205 N. Lincoln Blvd., Oklahoma City, Oklahoma. The meeting was held, as indicated, by advance notice filed with the Oklahoma County Clerk and by notice posted at the ACOG offices at least 24 hours prior to the meeting.

MINUTES.

1. CALL TO ORDER - INTRODUCTION OF GUESTS

Presiding Chair Brent Hawkinson called the meeting to order at 9:30 a.m.

2. APPROVAL OF MINUTES - MARCH 4, 2025 MEETING

Marvin Stanford made a motion to approve the March 4, 2025 minutes of the ACOG RPAC meeting. Kyle Hayes seconded the motion. The motion carried unanimously.

3. ITEMS FOR INFORMATION ONLY

A. NG911 IMPLEMENTATION STATUS REPORT

Mr. Hawkinson highlighted the information as detailed in the agenda memorandum regarding the NG911 Status Update. He said staff performed the Operational Readiness Test (ORT) with Mission Critical Partners (MCP), NGA and Comtech. He said the test was designed by MCP to perform in 2 phases, the Fail-Over and Functional. He said the Fail-Over test consists of 20 cases and all cases passed. He said the Functional test consists of 9 cases, and 2 of the cases failed. He said NGA prepared a route cause analysis on the first case that failed. He said Comtech is currently reviewing the issue and will reschedule the next ORT. He said the second test, using Multiprotocol Label Switching (MPLS) failed. He said NGA route cause analysis showed a configuration change. He said the abandoned calls are being investigated by Comtech, before staff can move forward. He said staff will notify the ECCs when the next end-to-end ORT is scheduled.

B. CURRENT 911 TECHNICAL SYSTEMS PROJECTS

Kale Littlefield said once the first ORT test is completed, staff will repeat the test every day until the second test. He said during that time staff will need to transfer calls to other agencies. He said staff will keep the committee informed.

C. UPDATE ON 911 TRAINING, UPCOMING INSTITUTE CLASSES AND OTHER TRAINING NEEDS

Robin Murray highlighted the upcoming 911 Training and Schedule. She said the Managing Different Generations class was accepted by APCO and will be taught at the National Conference by ACOG 911 Education Coordinator, Kristin Gonul. She said the list of upcoming 911 Institute of Oklahoma Classes is available on the ACOG website. She said the new training mandates require ECCs to have two 40-hour training courses. She asks the committee to notify her with their suggestions on scheduling for the PST1 class. Ms. Murray said the outline for the classes has been presented to the 911 Oklahoma Management Authority for review. She said a list of upcoming classes are available on the front table and to notify her with any questions.

D. RECENT 911 GEOGRAPHICAL INFORMATION SYSTEMS (GIS) ACTIVITIES

Tanner Jones said staff is still working with the 911 Management Authority on the process with the Oklahoma Tax Commission (OTC) and the Center for Spatial Analysis for any changes or updates your ECC or city may have to its boundaries. He said staff has received the data audit and is going through the results with the GIS departments. He said staff will sync up the road ranges, address points, and MSAG for your communities so that the 911 system can locate the calls more accurately. He said staff is working with ACOG vendor partner GeoComm to make sure those corrections get put into the GIS master dataset.

Mr. Jones said GIS is preparing the map updates for the Guardian workstations to have the latest GIS data available for the 911 dispatchers. He said the GIS data that will be distributed to the workstations will have the same up-to-date information that is in the ACOG GIS database. He said staff has cell tower routing updates, address requests, MSAG information updates, road additions and changes, and subdivision requests that are ongoing. He said staff is sending out the monthly GIS data push to the GIS PSAP contacts, and if anyone needs access or have any questions about the data, to please let staff know.

ECC UPDATE

Andrea Burgess said Del City has a new CAD System and is doing well. She said they are still having some staffing issues.

Ben Curry said Edmond has 3 openings and 1 new hire.

Whitney Byrd said Blanchard is fully staffed and has 2 new dispatchers and 1 graduate.

Kyle Hayes said Bethany is fully staffed.

Anna Carlise said Tuttle is fully staffed.
