WHY THE NEED FOR A 911 PHYSICAL STREET ADDRESS?

A specific address is vital in assisting emergency services in responding to an emergency call from your home or business. In an illness or injury, a faster response time can make a significant difference in survival and degree of recovery; in a fire, it can determine the amount of property saved; and in a police incident, it can mean a totally different outcome. Calling 911 automatically gives the dispatchers the address, allowing them to send the appropriate police, fire and medical personnel even if the caller is unable to communicate. Physical street addresses are also required for mail delivery and for other agencies such as utility companies, school districts, insurance companies, etc.

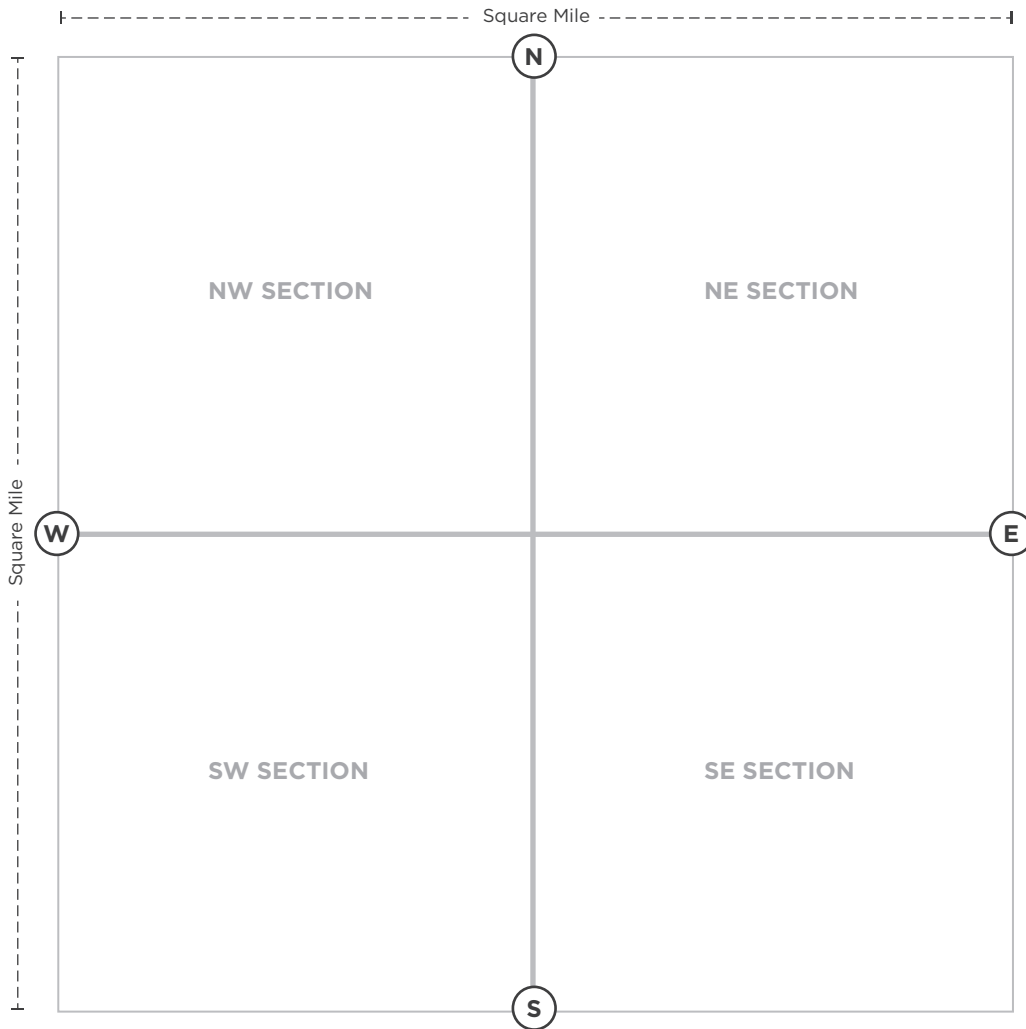
