**Central Oklahoma Long Range Transit Plan**

ACOG is exploring the items that should be included in implementation steps for the region going forward.

**Encompass 2050**

ACOG is planning for the next regional transportation plan – Encompass 2050. We have started meeting with the consultant and providing data to them.

**Legislative Meeting**

ACOG staff attended the annual Oklahoma City Chamber Transportation Committee legislative meeting. Many of their transportation legislative issues correspond to ACOG issues.

**ACOG Grants**

This month ACOG has been fielding questions and providing suggestions to cities that are applying for the three grants that close tomorrow at 4:00 p.m.

**ODOT**

ACOG had a quarterly financial meeting with the ODOT staff. This meeting was informative and may allow us to track funding for each of our grants in a more accurate way.

**Watch For Me**

ACOG's contract with the Oklahoma Highway Safety Office (OSHO) for Watch For Me campaign is on hold due to lack of federal funding.

**Intelligent Transportation Systems (ITS)**

ACOG is having the next regional Intelligent Transportation Systems Coordination Meeting on November 6. This meeting is to discuss the congested corridors and coordinate future investments that may help us travel in the region more safely and efficiently.

**Heartland Flyer**

ACOG staff is meeting with North Central Texas Council of Governments for preliminary discussions pertaining to the Heartland Flyer this Friday. They will be visiting the metro in mid-November. We hope to coordinate with them and discuss ways of retaining the Heartland Flyer.

**Forth Roadmap Conference**

David Frick attended the conference in Detroit, Michigan to learn more about transportation electrification strategies and technologies in support of Drive Electric Oklahoma.

**National Science Foundation CIVIC**

ACOG's Intern, Madison Martin, attended the conference in Washington D.C., in support of the University of Oklahoma Hudson College of Public Health and Shawnee Public Schools Recharge pilot project that will explore the use of electric school bus batteries as backup electricity during outages.

**Lithium-ion Batteries**

ACOG staff provided technical assistance to Representative Arturo Alonso Sandoval for a House interim study on Critical Minerals and Battery Stewardship. ACOG is working to advance House Bill 1907, which is focused on keeping lithium-ion batteries out of municipal waste process, which is a big fire hazard.

### PRELIMINARY 2050 ACOG TRANSPORTATION MANAGEMENT AREA (TMA) COUNTY AND CITY POPULATION PROJECTIONS

#### INFORMATION:

As part of the development of Encompass 2050, some control totals/guidelines for the 2050 population for the ACOG TMA are required. At the September Technical & Policy Committee meetings, staff presented county population projections for 2050. These projections were gathered from the Oklahoma Department of Commerce (ODOC) and Woods and Poole Economics Inc., and trend data were used to evaluate future county projections. Preliminary county projections that were selected are highlighted in yellow in Table 1.

For modeling purposes and scenario planning, the population forecasts for city level geography also have to be developed. As a starting point for 2050 population figures, each entity in each county was given the same portion of the county population total, as the 2020 base year. Next, staff looked at the recent population trends back to 2000 to see if this new 2050 population figure was realistic, based on trend data.

In some cases, local entities had comprehensive plans that had future population forecasts. These forecasts were included in Table 2 as a guide and had a wide variety of future year dates. If no forecasts were available, then "None" was listed in Table 2.

The Adjusted 2050 Column was added to provide more realistic estimates of future population forecasts. The 2050 population numbers highlighted in yellow show the adjusted numbers in Table 2. The 2050 TMA population total would then reach 1,914,666, an increase of 43.6 percent.

### **INFORMATION:**

In 2024, EMBARK, the City of Oklahoma City MAPS 4 office, and ACOG, in partnership with Norman Transit and Edmond Citylink, initiated the development of a Central Oklahoma Long Range Transit Plan (COLRTP). The first regional transit plan since the completion of the 2005 Fixed Guideway Study, the COLRTP consolidates prior transit planning efforts in Central Oklahoma, identifies existing and future needs, and outlines a vision for the development of transit services over the next 30 years.

The plan addresses four key project goals: provide communities with meaningful access to transit, create a compelling and reliable rider experience, offer competitive service options, and utilize resources effectively. The plan analyzes current transit trends, existing service levels, and key demographics to determine regional transit needs; identifies opportunities to address need by developing short-, mid-, and long-term planning scenarios; and recommends a phased series of cross-agency actions to help Central Oklahoma achieve a comprehensive, integrated transit system over the next 30 years.

Plan development was informed by a public engagement process that included a website and public comment platform, a series of virtual town halls, circulation of social media content, distribution of factsheets and other print materials, and presentations at nearly 30 public meetings across Edmond, Norman, and Oklahoma City.

The final plan will be presented for approval at the November meeting of the MPO Policy Committee. In advance of this meeting, committee members are encouraged to review the COLRTP report and appendices using the following links:

### INFORMATION:

During the 2025 ozone season (April through November) there were no Ozone Alert Days called but fourteen (14) instances of monitors exceeding the Environmental Protection Agency (EPA) ozone 8-hour standard of 70 ppb. The number of exceedances is less than the thirty-two (32) instances in 2024.

However, the 2025 regional design value for Central Oklahoma is 71 ppb – a violation of the ozone standard.

EPA's ozone pollution standard uses a three-year average to determine compliance, and the current standard is set at 70 ppb. At the unofficial end of the 2025 ozone season, the three-year average is 72 ppb. This means that if EPA were to designate the Oklahoma City Metropolitan Statistical Area (MSA's) ozone attainment today, the OKC-MSA would be out of attainment of the ozone standard.

The [\*ACOG Cost of Nonattainment Study for the Oklahoma City Area\*](#) has estimated \$9.6 - \$15.2 billion in negative fiscal impact to the region should that occur.

ACOG is implementing a [Regional Air Quality Plan](#) (RAQP) to improve air quality and keep the region in attainment of air quality standards.

Strategic areas of focus in the plan include:

- Transportation Emissions
- Industrial & Commercial Emissions
- Public Awareness & Community Engagement
- Local Government Tools & Policy Support

Key RAQP Goals include:

- Reducing NO<sub>x</sub> and VOC emissions from on-road vehicles by 15 percent
- Engaging 50-75 percent of local governments in clean air ordinances or fleet transitions
- Reaching 250,000 residents annually through Clean Air outreach
- Decreasing industrial and commercial emissions by 10 percent
- Converting 10 percent of municipal fleets to electric or hybrid
