A. CALL TO ORDER

Chair John M. Sharp called the meeting to order at 10:05 a.m.

B. APPROVAL OF THE OCTOBER 16, 2025, MINUTES

David Russell moved to approve the October 16, 2025, minutes. David Riesland seconded the motion. The motion carried unanimously.

C. ACTION ITEMS:

1. Amendments to the FFY 2024-2027 Transportation Improvement Program

Jennifer Sebesta said there are two amendment requests from the City of Norman and highlighted the information as detailed in the agenda memorandum.

Ryan Baker moved to recommend that the ACOG MPO Policy Committee amend the FFY 2024-2027 Transportation Improvement Program by updating the City of Norman FFY 2026 Transit Element with the attached program of projects, and submit the same to the Oklahoma Department of Transportation (ODOT) for amendment of the Statewide Transportation Improvement Program (STIP). Mayor Terry Arps seconded the motion. The motion carried unanimously.

2. Final Central Oklahoma Long-Range Transit Plan (COLRTP)

John Sharp highlighted the information as detailed in the agenda memorandum.

David Riesland moved to recommend that the ACOG MPO Policy Committee approve the Final Central Oklahoma Long Range Transit Plan, and incorporate it into ACOG's Metropolitan Transportation Plan. Davis Russell seconded the motion. The motion carried unanimously.

3. ACOG MPO Technical Committee Meeting Schedule for CY 2026

John Sharp presented the proposed CY 2026 meeting schedule for this Committee, noting that sometimes the committee will meet on the second Thursday of the month and sometimes on the third Thursday.

Emily Richey moved to recommend that the ACOG MPO Policy Committee approve the proposed CY 2026 ACOG MPO Technical Committee meeting schedule. Mayor Terry Arps seconded the motion. The motion carried unanimously.

D. ITEMS FOR INFORMATION ONLY:

1. Ozone Season 2025 Update

Eric Pollard said even though the number of exceedances were far fewer than in 2024, the Choctaw monitor had a number of exceedances in the spring months – March, April, and May, which pushed the total for being over the ozone standard to 71 ppb – a three-year average that is over the EPA standard. He said ACOG will be meeting with ODEQ to find out why those Choctaw numbers were higher and will share that information with the committee. He then highlighted the information in the agenda memorandum regarding the Regional Air Quality Plan, thanking those who have participated in helping to reduce ozone emissions.

Mr. Pollard said there will not be a designation until possibly 2029, so there is time in future ozone seasons to see where we will end up.

Mayor Arps asked ODEQ what were the effects of the Canadian wildfires which shot fire into the root system, going many miles in every direction. In the spring, those root

systems can come back up and ignite new fires - a continuing problem forever. How do those types of fires affect our region when they were states away from us.

Christina Hagens said ODEQ has evaluated the data and when another place generates pollution and it drifts to Oklahoma to affect our monitors, ODEQ assesses the situation. Cailyn Prather asked about the dust storms. Ms. Hagens said that since we have not been designated yet, ODEQ staff just conducts in-house studies to be prepared should we go into non-attainment.

Chairman Sharp asked if ODEQ write letters to EPA, notifying them of these trends/issues. Ms. Hagens said yes, they send an initial letter of the pollutants and EPA will flag it on the system. Then ODEQ works on the demonstration, pushes it back through, and if it gets approved, EPA will flag the data themselves.

Michael Glessner asked about the estimated \$9.6-\$15.2 billion cost in negative fiscal impact to the region. Chairman Sharp said that cost was determined in the ACOG Cost of Nonattainment Study when calculating permitting costs, delays, and additional funds having to be used by the DOT and local communities when working on projects. You must jump through more hoops when in nonattainment – more regulatory requirements that come with that, which we do not have at this time. Some of our competitiveness in the region is there because we are in attainment. If we go into nonattainment, we may come off the list of places where new businesses could be placed. That could be the cost over a period of time to doing business here locally.

Preliminary 2050 ACOG Transportation Management Area (TMA) County and City Population Projections

John Sharp highlighted the information as detailed in the agenda memorandum. There is concern about the adjusted 2050 totals, which are quite high. He said communities must have capacity to work with these numbers. The implication if these numbers are used is that traffic could vastly increase and additional water supplies and water treatment plants must be added. Not all the communities have the capacity for these things because it will cost more, and they do not want the chambers of commerce and builders to tell them what to do. Also, trips must be modeled, and all those added people must be loaded on the interstates, highways, and local streets. The region already has 39 corridors that are congested, and if you add 50 percent more people driving around the region, how will we deal with that?

Mayor Arps mentioned that he believes you cannot outbuild congestion by building more highway lanes. Instead, find ways to cause drivers not to have to travel so far. Mr. Sharp mentioned placemaking as a possibility, e.g., in the community have sidewalks to give access to the bank, hairdresser, grocery store, etc.

Justin Henry said Oklahoma City added 14-15,000 population totals per year and it did not seem to have a big impact on commuter trips. Cailyn Prather mentioned that working from home would be helpful.

E. NEW BUSINESS

Congestion Management Process Stakeholder Meeting 4

Chairman Sharp announced that there will be a Congestion Management Process Stakeholder Meeting at 11 a.m. today in this room. These meetings ensure that congestion management strategies move from planning to action.

Informal Bike Meeting at ODOT

Bart Vleugels said there will be an informal bike meeting at ODOT soon and ODOT will be sending out invites.

Grant Opportunities

Ethan Mazzio said there is a handout available at the table regarding current grant opportunities.

ENCOMPASS 2050 METROPOLITAN TRANSPORTATION PLAN (MTP)

INFORMATION:

As the Metropolitan Planning Organization (MPO) for Central Oklahoma, one of ACOG's primary roles is to conduct a comprehensive, coordinated, and continuing long-range planning process. To help accomplish this, ACOG works with area local governments, transit providers, the Oklahoma Department of Transportation, the Federal Highway and Transit Administrations, other transportation agencies and stakeholders, and the public to prepare a federally required Metropolitan Transportation Plan (MTP).

ACOG is currently in the process of updating the MTP in coordination with consultant Kimley-Horn. It is anticipated to be completed by November 2026. This update, known as Encompass 2050, sets a multimodal, long-term vision for the region's transportation system based upon locally developed goals and priorities. The 30-year plan includes both policy recommendations and specific projects, and functions as a responsible guide for maintaining and improving the current transportation system in the region.

At the December meeting, Kimley-Horn will present a brief overview of the long-range planning process and proposed timeline for achieving Encompass 2050 Plan adoption in fall 2026.

OKC METROPOLITAN STATISTICAL AREA (MSA) COMPREHENSIVE CLIMATE ACTION PLAN - TRANSPORTATION AND MOBILITY ACTIONS

INFORMATION:

ACOG has received planning funding for the EPA <u>Climate Pollution Reduction Grant (CPRG)</u> to develop a Comprehensive Climate Action Plan (CCAP) for the Oklahoma City Metropolitan Statistical Area (MSA).

Since receiving the EPA CPRG award in October 2023, staff held fifteen (15) county-by-county CPRG stakeholder meetings, conducted project input surveys, and have conducted numerous one-on-one meetings with ACOG member governments and stakeholders.

Based upon challenges and opportunities shared by cities and counties in meetings held in June 2025, ACOG CPRG Consultant Stantec identified twelve (12) proposed transportation and mobility action strategies (see Figure 1) that were then ranked at CPRG Stakeholder Workshops held in September 2025.

Top ranked action strategies selected include:

- Reduce fuel consumption by an average of 10% through the integration of cost-effective, engineered traffic solutions.
- Pilot the transition of 45 heavy-duty fleet vehicles to alternative fuel vehicles by 2030.
- Implement smart growth and multimodal infrastructure strategies to achieve a 10% reduction in on-road transportation greenhouse gas (GHG) emissions by 2050.
- Collaborate with ODOT to integrate local government input during project initiation for context-sensitive planning.

If all priority actions are implemented, the OKC-MSA transportation and mobility sector is projected to achieve 1.9 million metric tons of GHG avoided by 2050.

The ACOG Board accepted the CCAP at their November 20, 2025 meeting and was submitted to the EPA on December 1, 2025. Once the EPA confirms the plan meets grant requirements the full plan will be published on the ACOG website.

INFORMATION:

ACOG continues to provide information to members and committees on available grants. Below is information on a few open grant opportunities.

P3 Pooled Finance Program - Oklahoma Department of Commerce (ODOC)

- Program supports construction of public infrastructure that benefits the competitiveness of one or more for-profit businesses, and enables future economic growth for the local or regional economy.
- Local and private partner match required. Overmatch strengthens application.
- Eligible uses include pre-construction and construction activities for infrastructure such as roads, bridges, rail, transit, water infrastructure, buildings, and other publicly-owned assets.
- Applications are submitted by a local government and reviewed on an ongoing basis. Must include a project timeline, anticipated budget, and a list of for-profit entities involved.

INFORMATION:

As part of the development of the 2050 Metropolitan Transportation Plan (MTP), projections for future employment in the region are necessary. The ACOG TMA, county, and city level data are required for the MTP scenario planning. Below is a summary of the methodology.

In past plans, staff used Woods and Poole employment projections by county as a guide for development of the future ACOG TMA area numbers.

To determine the employment data by place of work, staff calculated the ratio between the 2020 ACOG TMA county, or portions of a county, employment totals (shown in Table 1) and the 2020 Woods and Poole full county totals. This ratio was then applied to the 2050 Woods and Poole figure to calculate the new 2050 ACOG TMA county data by place of employment totals.

After the County level forecasts were developed, the city level employment figures were calculated. As a starting point for 2050 employment figures, each entity in each county was given the same portion of the county employment total, as the 2020 base year. Then, past trends in employment growth, the Encompass 2045 Plan city employment totals, and 2050 Woods and Poole projections were used to develop the 2050 city level employment by county (Table 2). A comment field was added to identify how the preliminary 2050 population by city was chosen. Generally, the 2045 Plan, Woods and Poole (W&P), or ACOG staff recommendations were the options given. These employment projections lead to an employment growth rate of 48 percent in the ACOG TMA area between 2020-2050.
